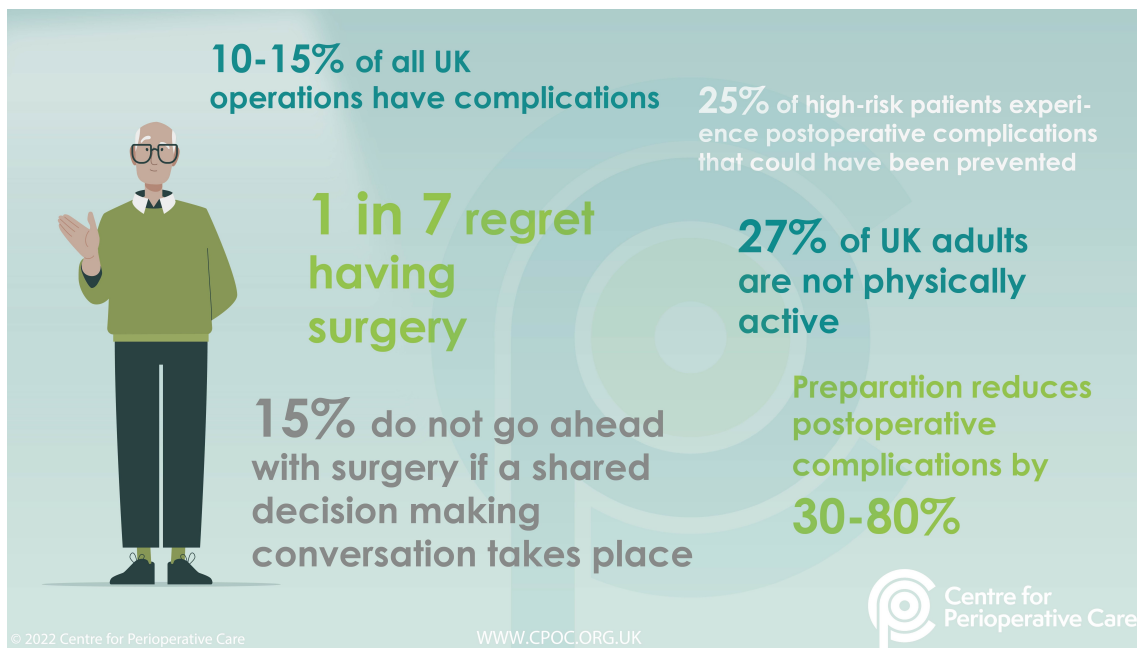


Welcome Professor Derek Alderson Confirmed Incoming Chair of the CPOC Board

PRSB Shared Decision Making Standard

The PRSB information standard on shared decision making provides a framework for clinicians to record the decision-making process between themselves and their patients. The standard also

allows the shared decision information to be shared between professionals and their different record systems. The standard has been developed based on the [GMC guidance](#) on shared decision-making and consent and the [NICE guidelines](#).

The standard sets out the information that should be recorded for a shared decision making discussion between a clinician and patient, and then shared afterwards with the patient and other professionals who care for them.

PIF TICK Criteria Updates

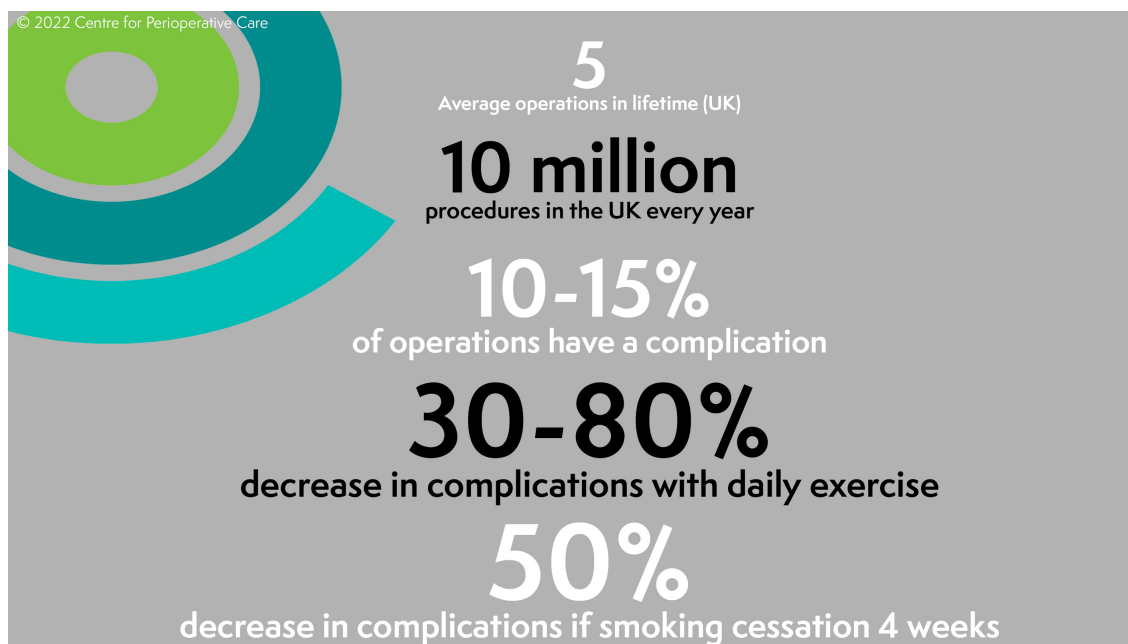
Are you a healthcare professional?

[The Patient Information Forum \(PIF\)](#) has launched an update to the UK's only assessed quality mark for print and digital health and care information.

Organisations must undergo a rigorous, independent assessment, proving they meet 10 criteria, to be awarded the PIF TICK.

The update places a greater emphasis on inclusion and reflects the huge evolution in health and care information since the PIF TICK was launched in 2020.
